NCW LAUNCHED "WE THINK DIGITAL" TRAINING ON THE OCCASION OF SAFER INTERNET DAY

National Commission for Women in collaboration with Facebook and Cyber Peace Foundation has launched the second phase of "We Think Digital" Campaign on the occasion of Safer Internet Day on 11th February, 2020 at Lucknow, Uttar Pardesh.

The internet has a huge potential in bridging the gender divide, studies have shown that access to the internet without awareness & guidance raises challenges. Almost all the users, especially in the smaller cities (tier II & III) are the 1st generation users of these new and emerging technologies and do not have any guidance or learnings. Women are highly vulnerable in this digital world to various types of crimes. Although limited, research on internet experiences and attitudes has found parallel gender differences, with females reporting lower levels of experience and more negative attitudes. It is a known fact that if you educate women, you educate an entire generation. It is, therefore, the urgent need of the hour to reach out to this demographic and inculcate Cyber Swachhta & Safe Online Practices amongst the women, at the same time raising awareness and enabling them to guide the younger generation.

'We Think Digital' training aims to empower women to be:

- AWARE of their Digital Rights and Responsibilities
- CHOOSE consciously by making Safe, Smart, Informed Choices
- HYGIENE conscious by following healthy online Practices
- **RECOGNISE** and Manage Online Risks
- **RESPONSIBLE** Netizens following rules & regulations

NCW has been working in technology governance especially for women, in policy review and advocacy, capacity and capability creation and building through partnerships with various government organizations, academic institutions and organization. At Phase-I, the Commission was successful in delivering at 9 States and trained One Lac women. At Phase-II, the training will cover 7 States in Uttar Pradesh, Gujarat, Madhya Pradesh, Bihar, Jharkhand, West-Bengal and Assam and target to train another One Lac women.
