5. Eligibility Criteria	Must be retired from Central Government/State Govt./PSU Services at the level of Section Officer or equivalent and above (Level 8 Pay Matrix as Per 7th CPC or above).
6. Age Eligibility	Candidates should not be more than 63 years on the date of Walk-in-Interview.
7. Experience	Must have experience in dealing with general administration matters such as procurement and contract management through GeM Portal, E-auction through Government portal.
8. Remuneration	A consolidated remuneration restricted to an amount equal to the last pay drawn minus pension plus DA on applicable rates. The total remuneration payable shall not exceed Rs.40,000/-. The Commission will have discretionary power to decide variation.
9. Leave	One day in each month to be availed during the validity of the contract.
10. Working hours	Normal office timings from 9.00 am to 5.30 pm. Marking biometric attendance is mandatory. May also have to devote more time than usual to meet the exigencies of work.
11. Term of engagement	The engagement will be on hire and fire basis which is purely dependent on their work performance.
