## NCW LAUNCHES DIGITAL SHAKTI 4.0 FOR SKILLING WOMEN & GIRLS IN CYBERSPACE









The National Commission for Women (NCW) launched the fourth phase of Digital Shakti Campaign, a pan-India project on digitally empowering and skilling women and girls in the cyberspace, run in collaboration with CyberPeace Foundation and Meta on November 15, 2022.

#### Monitoring Committee Meeting of 12 Pilot Special Cells for Women





The second Monitoring Committee Meeting of 12 pilot Special Cells for Women was held on 29th November, 2022 at Institute of Hotel Management, Rajbagh, Srinagar under the "Violence Free Home – A Woman's Right" project of the Commission in collaboration with Tata Institute of Social Sciences (TISS), Mumbai and Home & Social Welfare Department of UTs. The meeting reviewed progress of the work since the previous meeting held on 23rd May, 2022. It was suggested in the meeting that visibility be increased through collaborative outreach programmes as well as information to be put up on official websites of Social Welfare Department and Police.

The Special Cells for Women have been functional in both UTs since November 2021 and the trained Social Workers located in the Police system have been providing psycho-social-legal services to 2685 women survivors of violence with a clear understanding that violence against women is a crime and it is the responsibility of the State to prevent and counter the same.

#### Final Review of The Family Courts Act 1984





The National Commission for Women conducted the final Law Review Consultation on "The Family Courts Act, 1984" with legal experts on November 23, 2022 in order to review the existing law and its implementation in letter and spirit. The Consultation was chaired by Ms Rekha Sharma, Chairperson, NCW. The session was moderated by Ms. Priya Bhardwaj, Counsellor, Legal Cell. The Commission organized five Regional Consultations to incorporate viewpoints from diverse sectors and stakeholders from different suggesting regions process comprehensive changes in the law relating to the Family Courts Act.
