During the meeting, Ms. Rekha Sharma emphasized the significance of a coordinated and proactive approach in tackling the issue of human trafficking. She stressed the importance of prevention strategies and acknowledged the role played by Anti-Human Trafficking Units in raising awareness amongst the Women.


Ms. Meenakshi Negi, Member Secretary, National Commission for Women addressed the interns on "Functioning of NCW" as a part of the online short term internship.
