Editor's Column

Alarming rise in atrocities committed against domestic workers at the hands of their employers has highlighted the need to bring a central legislation to protect their rights and regulate this unorganized sector.

Most domestic workers, who hail from the marginalized sections of the society, perform essential household work in private homes and a large number of them are migrant workers. These workers face a wide range of human rights violations, including, excessive working hours without rest, non-payment of wages, forced confinement, physical and sexual abuse, forced labour and trafficking.

The domestic workers generally do not protest against the inhuman treatment meted out to them, but continue to suffer silently. Occasionally, only a few cases of such crimes come to light. Three years ago, the National Commission for Women had drafted the "Domestic Workers Welfare and

Social Security Act, 2010" Bill, highlighting the exploitative behaviour towards domestic workers. The Bill, however, is still hanging fire and yet to be passed.

The recent incident of extreme abuse and brutal treatment meted out to a domestic maid by an MLA and his wife is becoming a part of day-today city life and is testimony to the violation of human rights of domestic workers.

to safeguard the rights of domestic workers by recognizing domestic workers as 'workers' and employers' homes as 'workplaces', their working condition will not improve and exploitation will continue. As the domestic worker sector remains unregulated, the employers or the placement services, which place them in various households, will continue to enjoy immunity from law. Unless, the government fixes minimum wages and regulates working hours, interval for rest, weekly holidays, etc., domestic workers will continue to be subjected to inhuman treatment and many more extreme incidents are bound to take place. Moreover, the domestic workers are very often victims of human trafficking and later sold to people in the city, as domestic maids.

Many countries like the USA and the Italy do have Domestic Workers Act, which protects the rights of the workers, who are protected under the state human rights law, which also safeguards against racial and sexual harassment.

Our government, too, has an unquestioned responsibility to provide justice to the poor, illiterate and marginalized women, who very often turn up as domestic workers to supplement their meagre income. However, laws alone cannot help them; the workers must also be sensitized to their rights and should stand up against abuse and cruel treatment meted out to them.

Punjab hikes compensation to rape victims

The Punjab government has recently enhanced the compensation paid to rape and rape-cum-murder victims and their relatives. Maximum compensation of Rs. three lakh would be given to rape victims while up to Rs. four lakh would be given to the relatives of those murdered after sexual assault.

Earlier, the compensation amount was Rs. two lakh for rape victims and Rs. three lakh for rape-cum-murder.

Besides, the state government also gives compensation of Rs. 50,000 to victims of human trafficking, child-abuse and kidnapping, Rs. 10,000 for simple loss or injury to child victims and Rs. 20,000 for rehabilitation of women and children. Rs. three lakh is given to victims of acid attack in case of disfigurement of face and Rs. 50,000 for other cases and injuries.

Inquiries undertaken by NCW

- NCW Member, Hemlata Kheria, along with social activist Manasi Pradhan, enquired into media report appearing in different newspapers titled "teacher set on fire, blames official". Reportedly, a school teacher was set on fire in Odisha's Rayagada District, allegedly because she refused to withdraw a sexual harassment complaint against a sub-inspector of schools, who has been hiding for past two months. They also enquired into media report "30-year-old lady raped by six persons and photographs taken in mobiles in Banpur Thana, Khurda District, Odisha.
- The team enquired into a newspaper report titled "17-year-old girl held hostage for four days and allegedly gangraped by six men" at Bindhnima Village, Cuttack District, Odisha. They also enquired into media reports titled "Woman raped at gunpoint" in Odisha.
- Taking suo moto cognizance, Member Nirmala Samant Prabhavalkar inquired into a media report "minor gang raped by forcing her to consume alcohol." The incident took place near Goregaon in Mumbai.
- Dr Charu WaliKhanna chaired an Enquiry Committee to enquire into incidents of trafficking in Jharkhand. Dr WaliKhanna also chaired an Enquiry Committee to inquire into the incidents of trafficking in West Bengal.

The North East Cell

The Commission has decided to constitute a North East Cell in the NCW. The cell will handle complaints received from North East States on line or by post and take suo motu cognizance in respect of North East cases. It will also process research studies, seminars and legal awareness programme proposals received from the North East State Commissions for Women, Universities, research bodies, NGOs etc. The Cell will deal with administrative and organizational issues, legal reviews and monitor utilization of budgetary funds allocated for the North East region.

Well done NCW

The National Commission for Women appreciates the decision of the Chief Minister of Maharashtra. Shri Prithviraj Chavan and Minister of State for Women & Child Development for sanctioning Rs. three lakh to an acid attack victim. NCW Member Nirmala Samant Prabhavalkar had taken special interest in the case, and played an important role in getting the money sanctioned by the State Government.

Important Decisions

- A New Delhi trial court has acquitted a youth of the charge of raping and kidnapping a minor girl and termed their marriage valid and said that "Child marriage contracted with a female of less than 18 years or a male of less than 21 years would not be a void marriage but voidable one, which would become valid if no steps are taken by such a child seeking declaration of this marriage as void". The judge further pointed out that the girl had many opportunities to escape from the residence of the accused's friend in Bihar, where the duo lived as husband and wife, but she did not.
- A Division Bench of the Bombay High Court has ruled that Indian parents should be given preference in child adoption over NRIs, OCIs (Overseas citizens of India) and foreign nationals. The Bench said "only if a child is not accepted by Indian parents and the adoption agencies, on account of their experience, come to the conclusion that the child is not likely to be taken in adoption by Indian parents, then it should be shown to the foreign parents".
- A Delhi court has ruled that a woman has right over the property of her husband but she cannot claim a property of her parents-in-law. The court said "under no circumstances can she thrust herself on the parents of her husband or can claim a right to live in their house against their consent and wishes".
